TERMS AND CONDITIONS

1. Nominated Driver

- (a) The Hirer nominates a person/s specified in this Agreement as the driver/s of the Vehicle during the Hire Period and agrees that no person other than the Nominated Driver/s shall drive the Vehicle (except in case of emergency).
- (b) The Hirer warrants that the Nominated Driver/s have attained the age of **21 years** and possesses a current Australian State or Territory driver's licence (or an international driver's licence) for the class of Vehicle hired. Drivers, who are **21 years**, must have a full driver's licence and have held for at least one year. Drivers **under 25** may be subject to additional fees and restrictions.

2. Delivery of Vehicle

- (a) Upon completion of the necessary document and payment, Cocos Autos shall deliver the Vehicle to the Hirer or make it available for pick-up on the requested date with full tank of fuel.
- (b) The Hirer acknowledges that the Vehicle is in good working order at the time of taking possession of the Vehicle.

3. Return of Vehicle

- (a) At the conclusion of the Hire Period, the Hirer shall return the Vehicle to Cocos Autos by specified time in reasonably clean condition. Up to \$200 cleaning fee may apply if the condition is deemed to be unacceptable.
- (b) Refuel the Vehicle or pay Cocos Autos for any fuel cost incurred. Failure to do so will incur a filling charge of \$10.00 + amount top up at \$4.00 per litre.

4. Use of Vehicle

The Hirer shall ensure that the Vehicle:

- (a) is driven in a safe and diligent manner and due care is exercised at all times; and
- (b) is NOT driven on any beaches, unmaintained roads, through any saltwater including when roads under water at high tides or used to launch a boat \$5,000 damage fee applies.
- (c) \$500 Cut/Polish fee applies for any fresh scratches and/or paint damage on Vehicle body panels.

5. Accidents and Insurance

- (a) If the Vehicle is involved in an accident which results in injury or damage to any person, thing or Vehicle, the Hirer shall:
 - (i) immediately report the accident to the AFP and Cocos Autos;
 - (ii) be fully responsible for all costs incurred to repair the Vehicle;
 - (iii) be responsible for the first insurance excess of \$2,500 for damage of the Vehicle.
- (b) Cocos Autos shall on behalf of the Hirer insure the Hirer for third party insurance only.

6. Payment Policy

- (a) For direct bookings, a non-refundable deposit of **\$100** will be charged to nominated credit card provided on this Agreement. Remaining balance shall be made four weeks prior to travel.
- (b) Credit card payment incurs 1% surcharge to cover some of the Bank Merchant charges. We only accept Master and Visa cards.
- (c) Payment for bookings from a third party (e.g. a travel agent), the third party's payment policy applies.

7. Refund/Cancellation Policy

- (a) If a booked vehicle is cancelled and Cocos Autos is notified in writing of the cancellation: 0-7 Days prior to collection day NO refund; 8-15 Days prior to collection day 50% refund; 16-30 days prior to collection day 70% refund and 31 days prior to collection day full refund. \$50 cancellation/administration fee incurs for full refundable cancellations for third party bookings. Number of days are calendar days.
- (b) Cocos Autos is not liable for any loss or extra cost caused by Virgin flights disruptions. We strongly recommend that you obtain appropriate travel insurance.
